The Noteholders may cast their votes on the proposed resolutions either (i) through the service provider Kroll Issuer Services Limited ("**Tabulation Agent**") or (ii) directly vis-à-vis the Scrutineer in in their own name, through a legal representative, or through their own proxy.

Representatives of Noteholders or proxies who grant sub-proxy authority and who are legal entities or partnerships under German or foreign law must prove their authority to represent by submitting a current extract from the relevant commercial register or a corresponding confirmation.

Legal representatives (such as parents acting on behalf of their children or guardians acting on behalf of their wards) or officially appointed administrators (such as insolvency administrators) must prove their legal authority to represent by presenting the relevant documents (e.g., a certificate of appointment in the case of an insolvency administrator).
